3. Step-by-Step Process: HUF Kaise Banayein?

- Step 1: Affidavit Draft — 2-100 Non-Judicial E-Stamp Paper
- Step 2: Print & Notarize — 100 Non-Judicial E-Stamp Paper
- Step 3: PAN Card Apply — UTIITSL / NSDL Form 49A
- Step 4: Bank & Demat Account — HUF Current/Savings & Zerodha/Groww Demat Account

4. HUF Mein Paise Kaise Deposit Karein? (Tax-Free)

- Method A (Gift from Grandfather): Dadaji 11,000 / 100% Tax-Free! Section 56(2)(x)
- Method B (Interest-Free Loan from Members): Section 64(2)

5. Stock Traders Tax Savings Example (STCG 20%)

Metric	Personal Account (30% Slab)	Jalal HUF Account
STCG Profit	Rs. 5,00,000	Rs. 5,00,000
Basic Tax Exemption	Rs. 0 (Exhausted)	Rs. 3,00,000 (Tax-Free)
Taxable STCG	Rs. 5,00,000	Rs. 2,00,000
Tax at 20% STCG	Rs. 1,00,000 + Cess	Rs. 40,000 + Cess
Net Tax Savings	—	SAVED Rs. 60,000+!
